



Activecrypt Software Redistribution License Agreement

This License Agreement (“Agreement”) is a legal agreement between Activecrypt Software (“Activecrypt”), and <company> (“Licensee”), and is effective the date Licensee installs, downloads, copies or otherwise Uses **DbDefence** in whole or in part (“Software”). “Use”, “Uses” or “Used” means to access any of the files that are included with the Software, to develop an application that makes use of the Software, to consult any of the documentation included with the Software, or to otherwise benefit from using the Software. The Software is licensed, not sold. If Licensee has obtained a registered license from Activecrypt or an authorized reseller, Licensee is considered to be an authorized (“Authorized”) licensee.

1. GRANT OF DUPLICATION AND DISTRIBUTION LICENSE

The Software includes binary files (herein, “Redistributable Files”) intended for duplication and distribution by a Licensee that is Authorized. If Licensee is Authorized, Activecrypt grants Licensee the non-exclusive, royalty-free license to duplicate and distribute the Redistributable Files. Redistribution Requirements: If Licensee redistributes the Redistributable Files, Licensee agrees to (i) distribute the Redistributable Files only in conjunction with and as part of Licensee’s software application product(s) or use the software on all development systems used by the developer assigned by the Licensee; (ii) not supply any means by which an end users could incorporate the Software or portions thereof in their own products; (iii) not to use the Redistributable Files in software advertised as database encryption solution; (iv) indemnify, hold harmless, and defend Activecrypt from and against any claims or lawsuits, including attorney’s fees, that arise or result from the use and distribution of Licensee’s software application product; and (v) not permit further distribution of the Redistributable Files by end user(s) of Licensee’s software.

2. LICENSE RENEWAL

For a period of one year Activecrypt agrees to provide free software updates (if and when they become available) of the software purchased (which does not include titles by another name) via internet download. Licensee may non-interruptedly renew software updates annually to obtain an additional year(s) of free software updates. Technical support is provided free of charge, but Activecrypt reserves the right to limit or cease technical support to user with software older than one year.

3. REVERSE-ENGINEERING

Licensee acknowledges that the Software, in source code form, remains a confidential trade secret of Activecrypt and/or its suppliers and therefore Licensee agrees that it shall not modify, decompile, disassemble or reverse engineer the Software or attempt to do so. Licensee agrees to refrain from disclosing the Software (and to take reasonable measures with its employees to ensure they do not disclose the Software) to any person, firm or entity except as expressly permitted.

4. RESTRICTIONS

Licensee may not Use, copy, modify, translate, or transfer the Software, documentation, license key, or any of the files included with the Software except as expressly defined in this agreement. Licensee may not attempt to unlock or bypass any “copy-protection”, licensing or authentication algorithm utilized by the Software. Licensee may not remove or modify any copyright notice, nor the About dialog or the method by which it may be invoked without permission from Activecrypt Software. Licensee may not rent or lease the Software. Violations will be prosecuted to the maximum extent possible under the law.

5. LIABILITY DISCLAIMER

The Software is provided as is, without any representation or warranty of any kind, either express or implied, including without limitation any representations or endorsements regarding the use of, the results of, or performance of the product, its appropriateness, accuracy, reliability, or correctness. The entire risk as to the use of this product is assumed by Licensee. Activecrypt does not assume liability for the use of this program beyond the original purchase price of the software. In no event will Activecrypt be liable for additional direct or indirect damages including any lost profits, lost savings, or other incidental or consequential damages arising from any defects, or the use or inability to use these programs, even if Activecrypt has been advised of the possibility of such damages.

6. EXPORT LAW

Licensee acknowledges and agrees that the Software may be subject to export restrictions and controls. Licensee agrees and certifies that neither the Software nor any direct product thereof (e.g. any application software developed by Licensee that uses the Software) is being or will be acquired, shipped, transferred or re-exported, directly or indirectly, into any country prohibited by export restrictions and controls. Licensee bears all responsibility for export law compliance and will indemnify Activecrypt against all claims based on Licensee’s exporting the Software.

7. TERMS

This Agreement is effective until terminated. Licensee may terminate it by destroying the Software, all the Redistributable Files Licensee may have distributed, the documentation and copies thereof. This license will also terminate if Licensee fails to comply with any terms or conditions of this Agreement. Licensee agrees upon such termination to destroy all copies of the Software and of the documentation, or return them to Activecrypt for disposal.
